Insurance: This establishment does NOT participate with any insurance companies. We are not able to bill your insurance and cannot accept payment from insurance for the services performed or prescriptions received.

Payment: ALL PAYMENT IS EXPECTED AT THE TIME OF SERVICE, however, some

services may require a deposit in advance. This establishment and all subsidiaries* only accepts payment in the form of cash, VISA, MasterCard, American Express or Discover. WE do NOT accept checks.

Refund Policy: ALL SALES ARE FINAL. Before a service is performed please consider all the required protocols and side effects. We are committed to patient satisfaction and are available to answer any questions/concerns you may have in regards to the services we offer.

Appointments: Broken appointments represent a cost to us, to you and to other patients who could have been seen in the time set aside for you. We require a 24 hour notice for canceling or rescheduling of any appointment.

No Shows: Appointments canceled without 24 hours notice. If you no show will be \$100 fee and nonrefundable deposit.

The parties agree that the Federal Arbitration Act governs the interpretation and enforcement of this provision. The entire dispute, including the scope and enforceability of this arbitration provision shall be determined by the Arbitrator. This arbitration provision shall survive the termination of these Terms and Conditions.

Class Action Waiver

Any arbitration under these Terms and Conditions will take place on an individual basis; class arbitrations and class/representative/collective actions are not permitted. THE PARTIES AGREE THAT A PARTY MAY BRING CLAIMS AGAINST THE OTHER ONLY IN EACH'S

INDIVIDUAL CAPACITY, AND NOT AS A PLAINTIFF OR CLASS MEMBER IN ANY PUTATIVE CLASS, COLLECTIVE AND/ OR REPRESENTATIVE PROCEEDING, SUCH AS IN THE FORM OF A PRIVATE ATTORNEY GENERAL ACTION AGAINST THE OTHER. Further, unless both you and AuraMD agree otherwise, the arbitrator may not consolidate more than one person's claims, and may not otherwise preside over any form of a representative or class proceeding.
